





Alabama Coastal Foundation, Inc. - Request for Use of the Baldwin County Coliseum for the 2017 Baldwin County Water Festival

STAFF RECOMMENDATION

In accordance with the Real Estate Lease, between Baldwin County, Alabama, and the Baldwin County Cattle and Fair Association, Inc., inform the Baldwin County Cattle and Fair Association, Inc., that under Baldwin County's exclusive use provision found therein, Baldwin County is allowing the Alabama Coastal Foundation, Inc. the use of the Baldwin County Coliseum (19477 Fairgrounds Road, Robertsdale, Alabama) on October 25, 2017, to hold and conduct the 2017 Baldwin County Water Festival with the applicable rental charge waived as said Festival serves the public purposes of benefiting educational, recreational and child advocacy purposes; however, the Alabama Coastal Foundation, Inc. shall be responsible to pay the Baldwin County Cattle and Fair Association, Inc., for all pre-set up fees and post-clean up fees.

BACKGROUND INFORMATION

Previous Commission Action/Background Information: No.

The Alabama Coastal Foundation (ACF) has requested the use of the Baldwin County Coliseum in Robertsdale for its 2017 Baldwin County Water Festival on October 25, 2017 (see attached request). The initial request was approved by the Baldwin County Cattle and Fair Association which leases the Baldwin County Coliseum from the Baldwin County Commission. However, at this time, the ACF is requesting the Baldwin County Cattle and Fair Association waive the \$900.00 rental fee associated to their use of the Baldwin County Coliseum. The Baldwin County Cattle and Fair Association asked the ACF to present this request to the Baldwin County Commission. As a footnote, the ACF will be paying for all set up and clean up fees associated to the event. They asked only for the \$900.00 rental fee to be waived. The Real Estate Lease between the Baldwin County Commission and Baldwin County Cattle and Fair Association, under the section entitled "Covenants of the B.C. Cattle & Fair," provides in

pertinent part:

"The B.C. Cattle and Fair shall": ".... (b) allow the COUNTY exclusive use of the coliseum and arena without charge including, without limitation, any furnishings and personal property excluding computer equipment located therein, when such use does not conflict with any previously scheduled events of the B.C. Cattle & Fair Association"

The above staff recommendation will inform the Baldwin County Cattle and Fair Association that the ACF will use of the Baldwin County Coliseum with the applicable rental fee waived; however, the ACF shall be responsible to pay the Baldwin County Cattle and Fair Association for all pre-set up fees and post-clean up fees.
