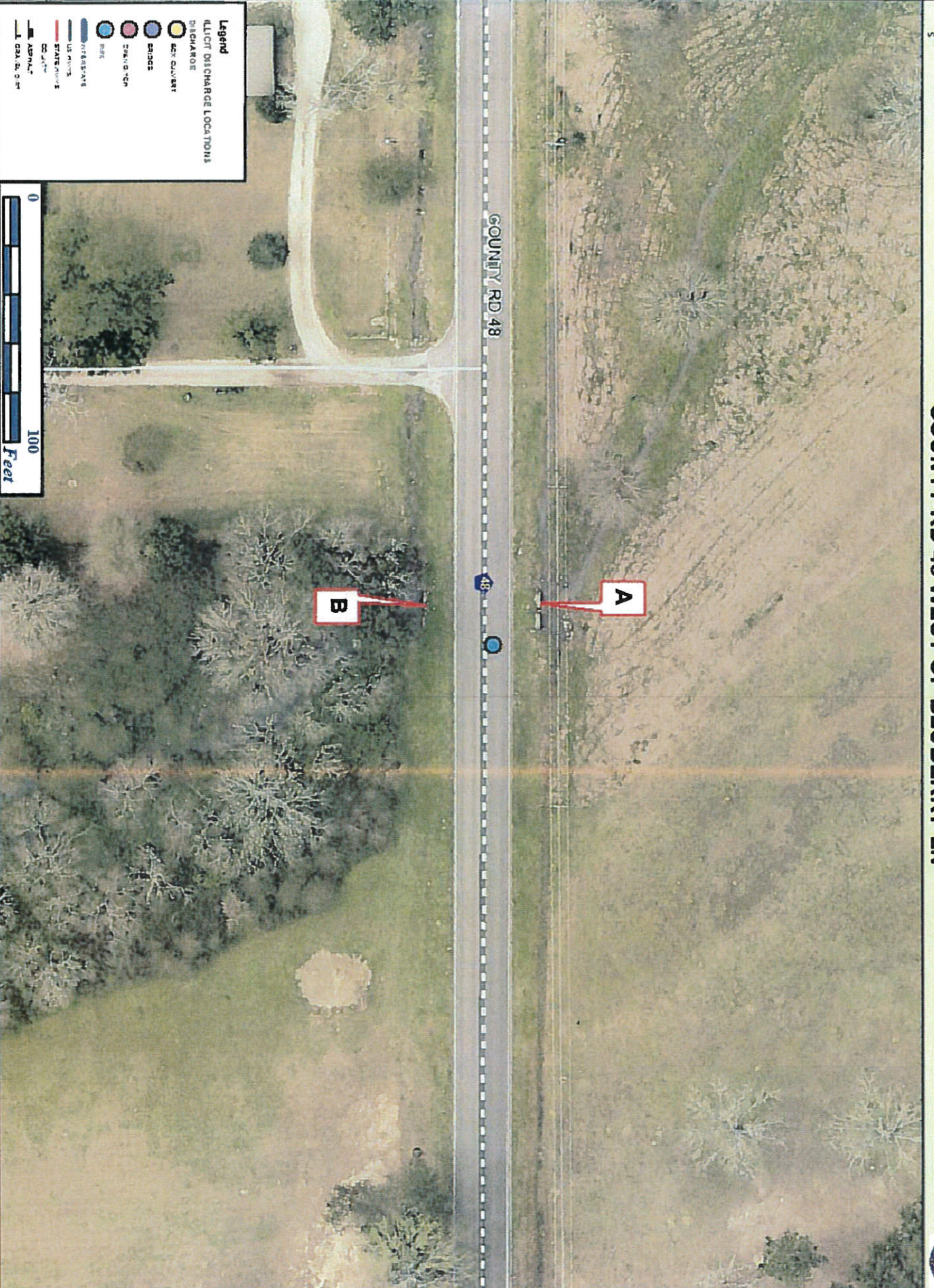

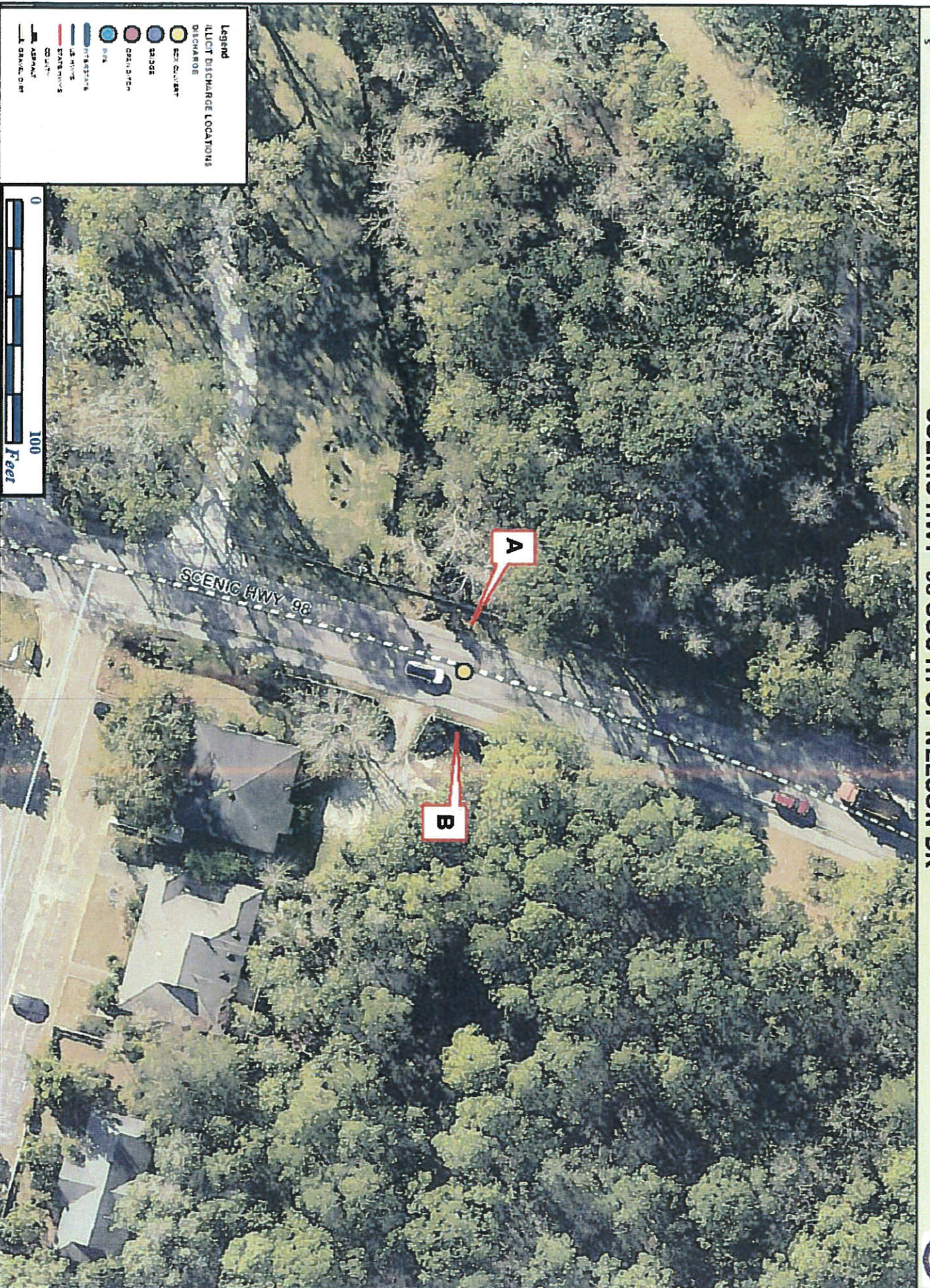

**Activity Code Number:** 503

**Administered by:** Operations Section

**Definition/Scope:** This process is used by Baldwin County Highway Department employee(s) for dealing with spills that may contain hazardous materials. Any dangerous good (solid, liquid or gas) that can harm people, other living organisms, property or the environment is considered a hazardous material.

**Customer:** The customers for this process are the County Commission, the County Engineer, Department Heads, Citizens, Environmental Agencies and Highway Department staff.

**Objectives:** **LIFE SAFETY FIRST – I'M SAFE, YOU'RE SAFE, WE'RE SAFE**

- If safe to do so, remove any victim(s) from the immediate vicinity of the spill, remembering that they are contaminated
- Consider evacuation

Please refer to the 1996 North American Emergency Response Guidebook

**Implementation Plan:** (for spills containing petroleum based products)

- Spill only – less than 25 gallons, not in water – notify supervisor, dyke product to prevent runoff and initiate clean up procedures
- Spill only in excess of 25 gallons or in water – notify 911 and request EMA, notify supervisor, notify ADEM, dyke product to prevent runoff, and notify hazmat contractor for clean up
- Spill with injury – call 911 and request EMS, Fire Department and EMA, notify supervisor to notify HR, dyke product to prevent runoff (quantities still apply)

**Critical Information:**

- On Scene Contact Name
- On Scene Contact Number
- Location –physical address, street, mile marker, direction (East, West etc.)
- City or County
- Road/Lane closures
- Type of material spilled

Please refer to the attached contractor contact list for cleanup contractors needed during spills.

**Follow-up Plan:** Actions shall be taken to minimize the spill location

**Procedure to Accomplish:**

**Responsibilities Summary:** The Baldwin County Highway Department shall take immediate precautionary measures to ensure the spill is contained and the appropriate authorities have been notified.

**Activity Code Number:** 503

**Administered by:** Operations Section

**Definition/Scope:** This process is used by Baldwin County Highway Department employee(s) for dealing with detection of sewer leakage / spills.

**Customer:** The customers for this process are the County Commission, the County Engineer, Department Heads, Citizens, Environmental Agencies and Highway Department staff.

**Objectives:**

- County Employee performs routine site inspection
- The following parameters shall be looked for during the inspection:  
Grayish Turbidity, Odor, Floatables, Algae-growth and Bacterial growth.
- If any of the above are detected during the inspection, sanitary sewer or a failing septic system may be the root of the problem.
- The County shall immediately notify the Baldwin County Health Department at 251-947-3618.

**Implementation Plan:**

- In the event that sewer spill is detected, the following parties shall be notified:
  - Supervisor
  - Health Department
  - ADEM
  - Utility / Facility Owner (as applicable)

**Activity Code Number:** 503

**Administered by:** Operations Section

**Definition/Scope:** This process is used by Baldwin County Highway Department employee(s) dry weather screening.

**Customer:** The customers for this process are the County Commission, the County Engineer, Department Heads, Citizens, Environmental Agencies and Highway Department staff.

**Objectives:**

- Conduct inspections during dry weather periods
- Characterize and record observations on basic sensory and physical indicators

**Implementation Plan:**

- If an illicit discharge is detected, please follow the Illicit Discharge Standard Operating Procedure

**Follow-up Plan:**

- Perform inspections of MS4 area at least once per permit cycle.
- If dry weather flow is present at the outfall, and the flow does not appear to be an obvious illicit discharge, attempt to identify the source of the flow then document the discharge for future comparison.
- Fill out MS4 Outfall Inspection Form
- Take photos for record.

**Procedure to Accomplish:**

**Responsibilities Summary:** The Baldwin County Highway Department employee responsible for performing dry weather screenings shall be responsible for implementing this SOP.

According to the EPA an illicit discharge is defined as any discharge to the municipal separate storm sewer system that is not composed entirely of storm water, except for discharges allowed under a NPDES permit or waters used for firefighting operations.

**Customer:** The customers for this process are the County Commission, the County Engineer, Department Heads, Citizens, Environmental Agencies and Highway Department staff.

**Objectives:**

- Document observations using the outfall reconnaissance field sheet
- Document site location
- Visually inspect general area for possible sources of discharge
- Take photos
- Collect samples if possible
- Complete the Illicit Discharge Inspection Form

**Implementation Plan:**

- In the event that illicit discharges do occur, the following parties shall be notified:
  - Supervisor
  - Health Department
  - ADEM
  - Utility / Facility Owner (as applicable)

Please refer to the contractor contact list for cleanup contractors needed during spills.

**Follow-up Plan:**

**Procedure to Accomplish:**

- Actions shall be taken to minimize illicit discharges. These actions shall include good construction practices as well as the installation and maintenance of BMP's.

**Responsibilities Summary:** The Baldwin County Highway Department employee responsible for performing dry weather screenings shall be responsible for implementing this SOP.

**Objectives:** Find Outfall Reconnaissance points and map locations

**Implementation Plan:** Follow this procedure for Outfall Reconnaissance points.

**Follow-up Plan:** Use maps as a guide for locations to take samples at Outfall Reconnaissance points.

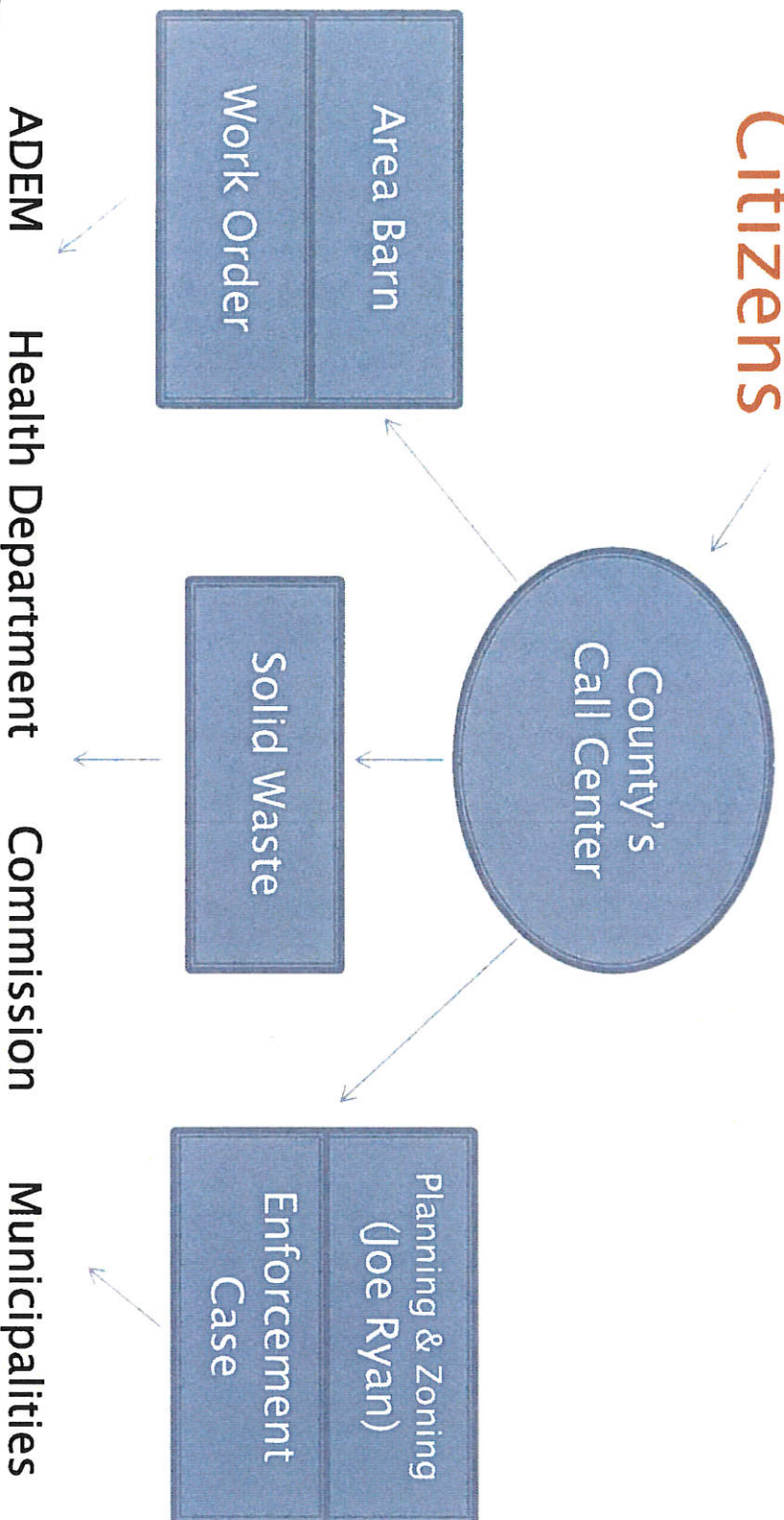
**Procedure to Accomplish:** See below

- Use USGS maps to identify perennial and intermediate streams in the MS4 area
- Use the county GIS database to overlay the USGS map with the county maintained road system
- Identify the locations where the two intersect. These are your outfall locations
- Label the outfall locations numerically
- If more than one of their points intersects state waters at the same location, identify those additional location's with sub letters i.e. A,B,C,D
- Field verify all locations to ensure conditions are accurately captured
- Capture subwatershed, latitude, longitude, and fill out Outfall Inspection form
- Create a location map of each inspection point to attach to the Outfall Inventory Inspection form
- Inspect the outfall every 5 years

## YOU ARE HEREBY NOTIFIED THAT:

Pursuant to the Baldwin County Zoning Ordinance, Sec. 21.3, notice is hereby given that you are in **violation** of the *Baldwin County Zoning Ordinance*.

### I. LOCATION OF VIOLATION:

The subject property is situated in Planning District 26, and is zoned B-2, Neighborhood Business District. The subject property is located at:

### II. NATURE OF VIOLATIONS:

The construction and addition of "Decks" attached to the existing structure with the following violations:

- 1.) The "Decks" do not meet the rear yard setback requirements of the *Baldwin County Zoning Ordinance*.
- 2.) The "Decks" were not included on the site plan which was submitted for Conditional Use approval (Case P-15001) and are not authorized.
- 3.) A "Land Use Certificate" was not submitted prior to the construction of the "Decks".

### III. CORRECTIVE ACTIONS:

- 1.) Remove the "Decks" and bring the structure into compliance with the *Baldwin County Zoning Ordinance* and all applicable rules and regulations within 30 days of the date of this notice.



- 2.) Apply for setback variances from the Board of Adjustment for Baldwin County Commission District 2 within 30 days of the date of this notice. Please note that the deadline for compliance is not automatically extended by the filing of a request for a variance.
- 3.) In the event setback variances are approved, return to the Baldwin County Planning and Zoning Commission with an updated Conditional Use application, including a detailed site plan showing the location of the "Decks".
- 4.) In the event the setback variances and the updated Conditional use are approved submit a complete application for a "Land Use Certificate" along with a detailed site plan for review and approval by the Baldwin County Planning and Zoning Department.

#### IV. ZONING ORDINANCE PROVISIONS:

The following articles and sections from the *Baldwin County Zoning Ordinance* are applicable:

##### Decks and Required Setbacks

###### Article 22 Definitions

###### Section 22.1 Usage

Except as otherwise provided herein, all words shall have the customary dictionary meaning. The present tense includes the future tense and the future tense includes the present tense. The singular number includes the plural and the plural includes the singular. The word "person" includes a firm, corporation, association, organization, trust, or partnership. The word "building" includes "structure." The words "shall" and "will" are always mandatory. The word "used" or "occupied" as applied to any land or buildings shall be construed to include the words "intended, arranged, or designed to be used or occupied."

###### Section 22.2 Words and Terms Defined

As used in these ordinances, the following words and terms shall have the meaning defined:

***Deck.* A flat uncovered area generally adjoining a house, building, or pool which may be used as an outdoor sitting or recreation area.**

###### Article 12 General Requirements

###### Section 12.5 Yard Requirements

12.5.1 Every part of a required yard or court shall be open from its lowest point to the sky unobstructed, except for the ordinary projection of sills, cornices, buttresses, ornamental features, chimneys, flues, and eaves, provided such projections shall not



extend more than 2-feet beyond the yard area requirements. (For additional provisions see *Section 22.2, Definitions* "Accessory Structure" and "Structure")

12.5.2 Yard requirements shall be modified subject to the following conditions:

(a) Through lots shall provide the required front yard on each street.

(b) Decks and unroofed porches may project into a required front yard for a distance not to exceed 5-feet and a required rear yard a distance not to exceed 10-feet.

(c) Uncovered steps and handicap ramps may project into a required front, or side yard for a distance not to exceed 5-feet and a rear yard not to exceed 10-feet.

(d) On a corner lot, the side yard from the side lot line which abuts a street shall be a minimum of 20-feet.

(e) Where a subdivision has been approved by the Planning Commission in accordance with the *Baldwin County Subdivision Regulations* prior to the enacting of zoning ordinances with front, rear or side yard setbacks different than the minimums required herein, the setbacks as recorded on the plat shall apply.

(f) All buildings or structures located within coastal high hazard areas (V-zones) shall be located 50-feet landward of the reach of the mean high tide.

### Conditional Use Approval

#### Section 18.11 Conditional Uses

18.11.1 *Authorization.* The Planning Commission may, under the prescribed standards and procedures contained herein, authorize the construction or initiation of any use that is expressly permitted as a conditional use in a particular zoning district; however, the county reserves full authority to deny any request for a conditional use, to impose conditions on the use, or to revoke approval at any time, upon finding that the permitted use will or has become unsuitable and incompatible in its location as a result of any nuisance or activity generated by the use.

18.11.3 *Submission requirements.* No request for conditional use approval shall be considered complete until all of the following has been submitted:

(a) *Application form.* The application shall be submitted on forms to be provided by the Zoning Administrator.

(b) *Plans and specifications.* Each application for conditional use approval shall be accompanied by an accurate site plan drawn to scale showing:



the actual shape, dimensions and size of the lot to be built upon, the size, shape, height, floor area and location of the buildings to be erected; dimensions and locations of existing buildings; width of front, side and rear yards; existing and proposed parking; ingress to and egress from the site; and such other information as may reasonably be requested to determine compliance with these zoning ordinances including but not limited to a landscaping plan, erosion control plan, stormwater management plan, and utilities plan.

(c) *State and Federal permits.* Written evidence of applications for all required permits showing compliance with regulations of the Corps of Engineers, Alabama Department of Environmental Management, Alabama Coastal Area Management Program and Baldwin County Health Department shall accompany the application for conditional use approval, and the conditional use may be conditioned upon the actual receipt of said permits by the applicant.

(d) *Application fee.* The applicant for a conditional use shall be required to pay an application fee according to the current schedule of fees established by the County Commission for the particular category of application. This fee shall be nonrefundable irrespective of the final disposition of the application.

**18.11.5 Conditions and restrictions on approval.** In approving a conditional use, the Planning Commission may impose conditions and restrictions upon the property benefited by the conditional use approval as may be necessary to comply with the standards set out above, to reduce or minimize any potentially injurious effect of such conditional use upon the property in the neighborhood, and to carry out the general purpose and intent of the ordinances. In approving any conditional use, the Planning Commission may specify the period of time for which such approval is valid for the commencement of the proposed conditional use. The Planning Commission may, upon written request, grant extensions to such time allotments not exceeding 6 months each without notice or hearing. Failure to comply with any such condition or restriction imposed by the Planning Commission shall constitute a violation of these ordinances. Those conditional uses which the Planning Commission approves subject to conditions shall have specified by the Planning Commission the time allotted to satisfy such conditions.

#### Land Use Certificate Requirement

#### Article 18 Administration

#### Section 18.1 Administration, Interpretation and Enforcement

#### Section 18.2 Land Use Certificates

**18.2.1 Authorization.** A land use certificate shall be obtained from the Zoning Administrator prior to the commencement of development and issuance of any building permit including electrical, HVAC and plumbing permits.



## V. ENFORCEMENT PENALTIES:

Failure to comply within the time specified above will subject you to penalties in accordance with Sec. 21.3 and Sec. 21.4 of the *Baldwin County Zoning Ordinance*:

21.3.8 Fines. Any person(s) violating any of the provisions herein shall be fined not more than \$150.00 for each separate violation, plus all costs of court, with each day such violation continues constituting a separate violation. The fines provided for herein shall commence and accrue upon receipt of the Notice of Violation or the expiration of the allowed period for correction, whichever is later. Said fines shall continue to accrue until paid, but shall not accrue on days during which the violation is properly on appeal.

## VI. ADDITIONAL INFORMATION AND APPEALS:

- If you believe the activities or conditions described above are not in violation of the *Baldwin County Zoning Ordinance*, you may provide supporting documentation or other materials to the Planning and Zoning Department at, 22070 Highway 59, Robertsdale, Alabama 36567 (physical address) or 22251 Palmer Street, Robertsdale, Alabama 36567 (mailing address) within 7 days of receipt of this notice for consideration. However, the deadline for compliance will not be extended by providing such information.
- Please note: This determination may be appealed to the appropriate Board of Adjustment. Appeals shall be filed within (15) fifteen days of the Date of Notice above, on forms provided by the Planning and Zoning Department. Appeals must be filed with the Board of Adjustment by delivery of the appeal form to the Planning and Zoning Director at his/her office in Robertsdale, Alabama, 22070 Highway 59, Robertsdale, Alabama 36567 (physical address) or 22251 Palmer Street, Robertsdale Alabama 36567 (mailing address). Appeal forms are available at the Planning and Zoning Department in Robertsdale, the Foley Satellite Courthouse, or on the County website at the following address:
