(Proposed by Act No. 2007-353)</p> <p>Local Amendment No. 2    <b>YES</b> ←</p> <p>Local Amendment No. 2    <b>NO</b> ←</p> <hr/> <p><b>SPECIAL COUNTY BOND AND TAX ELECTION</b>          Shall Baldwin County, Alabama, be authorized (1) to issue not exceeding \$70,335,000 principal amount of its general obligation bonds, in one or more series, for the purposes of constructing and improving in said County those certain hard surfaced roads, hard surfaced bridges and surface water drainage facilities, or any thereof, that were particularly described in that certain Resolution and Order No. 2008-88 adopted by the Baldwin County Commission on April 1, 2008; the aforesaid bonds to bear interest at a rate not exceeding six percent (6.00%) per annum, payable semiannually (except that the first interest payment date with respect to such bonds may, in the discretion of the aforesaid County Commission, be on a date other than the date that is six months after the date of such bonds), and to mature on the anniversary of the date of said bonds in years and amounts as follows: \$13,250,000 in 2009; \$13,645,000 in 2010; \$14,055,000 in 2011; \$14,475,000 in 2012; and \$14,910,000 in 2013; said bonds to be secured by the full faith, credit and taxing power of the said County and to be additionally secured by a pledge of so much as may be necessary therefor of the proceeds of the special tax hereinafter described, and (2) to levy annually, in addition to all other taxes now authorized, and for the purposes specified in that certain Resolution and Order No. 2008-89 adopted by said County Commission on April 1, 2008, a special county ad valorem or property tax at the rate of four (4) mills on the assessed valuation of taxable property in said County [equivalent to forty cents (40c) on each \$100 of the assessed value of such taxable property], for a period of five (5) years, commencing with the tax year of said County that began on October 1, 2007 (for which county taxes will become due and payable on October 1, 2008), and continuing until and including the tax year of said County beginning on October 1, 2011 (for which county taxes will become due and payable on October 1, 2012), for the combined purposes of providing for the payment of the principal of and interest on the aforesaid bonds, and paying costs of constructing and improving hard surfaced roads, hard surfaced bridges, and surface water drainage facilities, or any thereof, in Baldwin County?</p> <p><b>FOR</b> proposed \$70,335,000 General Obligation Bond issue and proposed 4-mill County tax ←</p> <p><b>AGAINST</b> proposed \$70,335,000 General Obligation Bond issue and proposed 4-mill County tax ←</p> <hr/> <p style="text-align: center;"><b>END OF BALLOT</b></p>
